Suggested wording for a bequest in a Will or a Codicil:

**For Canada:**

*I direct my Executor to donate \$\_\_\_\_\_ (or \_\_\_\_\_% of the residual interest in my estate) to Estonian Arts Centre ("Charity"), Registration No. 889875191 RR 0001, or its successor, on the condition that the recipient is a registered charity as defined by the Income Tax Act (Canada), as amended from time to time, at the time of the gift. If this condition cannot be satisfied then I direct my Executor to donate that sum to the Estonian Foundation of Canada, Registration No. 891452575 RR 0001, on the condition that it is a registered charity as defined by the Income Tax Act (Canada), as amended from time to time, at the time of the gift.*

**For United States of America:**

*I hereby bequeath \$\_\_\_\_\_ (or \_\_\_\_\_% of the residue of my estate) to International Estonian Centre US Fund held by the King Baudouin Foundation United States, Inc., a New York state not-for-profit corporation whose principal office is presently located at 10 Rockefeller Plaza, 16th Floor, New York, New York, 10020 or any successor charitable organization.*

United States Tax Information:

*International Estonian Centre US Fund held by the King Baudouin Foundation United States, Inc.* is a charitable organization described in Sections 170(b)(1)(A), 170(c), 2055(a) and 2522(a) of the Internal Revenue Code of 1986, as amended (the "IRC"). The IRS has determined the *International Estonian Centre US Fund held by the King Baudouin Foundation United States, Inc.* to be a public charity described in IRC Sections 509(a)(1) and 170(b)(1)(A)(vi). Lifetime gifts by individual donors are eligible for a federal income tax charitable deduction, and testamentary gifts are eligible for a federal estate tax charitable deduction. *International Estonian Centre US Fund held by the King Baudouin Foundation United States, Inc.*'s federal tax identification number is 58-2277856.
